

**BYLAW NO. 2017-04**

**A BYLAW OF THE VILLAGE OF BETHUNE TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER**

COUNCIL of the Village of Bethune, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Municipality's water supply system and sewer services shall make application to the officials of the Municipality. Each application shall be accompanied by the payment of a fee in the sum of \$100.00 for a 5/8" meter and \$150.00 for a 3/4" meter.
2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
3. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
4. Accounts for water service and/or sewer service shall cover a period of **one month** and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of **\$50.00** to cover the expenses of turning off the water and turning it on again.
5. The Municipality may by bylaw, ration or limit the amount of water furnished to and and/or all consumers should circumstances warrant such actions.

6. Bylaw No. 2016-02 is hereby repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.
