## THE VILLAGE OF BETHUNE

a Municipal Corporation, in the Province of Saskatchewan (Hereinafter referred to as the Municipality)

- and -

LUMSDEN & DISTRICT HERITAGE HOME INC. a non-profit corporation in the Province of Saskatchewan, (Hereinafter referred to as the Corporation)

WHEREAS the Corporation is a duly incorporated non-profit corporation according to the laws of the Province of Saskatchewan with a head office located or situated at Lumsden in the Province of Saskatchewan.

AND WHEREAS the Corporation intends to raise the necessary capital or a part thereof, required to construct and equip the said housing and/or special-care home accommodation by the sale of membership interests to municipal corporations in the Province of Saskatchewan.

## NOW THIS AGREEMENT WITNESSETH:

- 1. The Municipality agrees to purchase, and the Corporation agrees to sell to the Municipality 12,915 membership interests of a nominal sum of \$1.00 each, and payment to be made as follows:

  On September 30, 1986 \$8,610.00 and the balance of \$4,305.00 no later

  than September 30, 1987
- The Corporation and the Municipality agree that the Municipality shall have \_\_\_\_\_ representative(s) appointed by the Municipality to the Board of Directors of the Corporation.
- It is agreed that the Board of Directors shall have absolute control as to the organization, construction, operation and general management of the Corporation.
- 4. The Municipality agrees with the Corporation that if in any fiscal year, the accommodation provided by the Corporation shall operate at a loss or deficit, then such loss or deficit shall be paid by the Municipality to the Corporation in such proportionate sum as the membership interests purchased by the Municipality bears to the membership interests sold by the Corporation.
- 5. The Corporation agrees with the Municipality that, if for any reason it becomes necessary to wind up the Corporation, the assets of the Corporation available for distribution after paying all liabilities shall be distributed or disposed of to charitable organizations which carry on their work soley in Canada.
