THE COUNCIL OF THE VILLAGE OF BETHUNE, HEREBY ENACTS AS FOLLOWS:

- This Bylaw shall be known as "The Bethune Community Sports Centre Inc. Agreement Bylaw".
- 2. In this Bylaw,
 - (a) "Council" means the Council of the Village of Bethume.
- The Councl may participate in the establishment and operation of a community sports centre to be known as The Bethune Community Sports Centre Incorporated.
- 4. The Council may specifically enter into the Agreement, a copy of which is hereunto attached to this Bylaw as Schedule "A".
- The Council has reviewed the contents of the Agreement and consents to its term.

Memorandum of Agreement made this 9th day of February Between: The Rural Municipality of Dufferin No. 190 The Village of Bethune The Village of Findlater Whereas, pursuant to the provisions of Bylaw No. 2/88 of the Rural Municipality of Dufferin No. 190, Bylaw No. 2/88 of the Village of Bethune, and Bylaw No. 1/88 of the Village of Findlater, the parties hereto are authorized to enter into an agreement to provide for the sharing of the construction costs of a recreational facility and the operating and maintenance expenses thereof according to the details as follows: The facility involved is the new skating arena to be located in Bethune and to be known as The Bethune Community Sports Centre Incorporated; Each Municipality shall make a grant allocation to share in the capital costs of the project; The Municipalities will share in the operating and maintenance costs of the facility at the same level as the Municipality contributed to the cost of the construction of the facility in comparison to the total project cost for two years, 1988 to 1989. The designated and controlling authority of the facility will be the Bethune Community Sports Centre Incorporated.
