## BYLAW OF THE VILLAGE OF BETHUNE

# IN THE PROVINCE OF SASKATCHEWAN, TO PROVIDE

## FOR THE LICENSING OF HOME BASED BUSINESSES

A BYLAW TO ADOPT A SCALE OF LICENCE FEES FOR HOME BASED BUSINESSES WHICH ARE EXEMPTED FROM BUSINESS ASSESSMENT, ENACTED PURSUANT TO SECTION 105 (4) OF THE URBAN MUNICIPALITY ACT, 1984

The Council of the Village of Bethune in the Province of Saskatchewan, enacts as follows:

- In this bylaw the expression "Home Based Business" shall have the meaning ascribed to it by The Urban Municipality Act, 1984.
- No person shall carry on any home based business within the municipality unless he/she has in his/her possession a valid and subsisting licence for the purposes issued in accordance with the provisions of this bylaw.
- The Clerk/Administrator of the municipality is hereby 3 . authorized to issue a license to any person carrying on a home based business in the municipality:
  - who is not assessable by the municipality for the purposes of business taxation in respect to that business.
- The fee payable for a home based business under this bylaw shall be \$50.00.
- 5 . A list of permitted home occupations is attached as Schedule "A" to this bylaw.
- 5 . Any person who contravenes the provisions of this bylaw is guilty of an offence and upon conviction, shall be liable to the Penalty provided for by the General Penalty Bylaw of the Municipality.
