BYLAW NO. 2014-03

A BYLAW OF THE VILLAGEOF BETHUNE TO FIX THE RATES TO BE CHARGED FOR DUMPING BULK LIQUID SEWAGE HAULED TO THE MUNICIPAL LAGOON

COUNCIL of the Village of Bethune, in the Province of Saskatchewan, enacts as follows:

1. The municipality shall charge the following amounts to haulers of raw sewage effluent for disposal and treatment at the Village of Bethune lagoon site;

```
i. 1-2,000 gallons - $15.00
ii. 2,001-4,000 gallons $25.00
iii. 4,001-6,000 gallons $40.00
iv. >6,001 gallons $60.00
```

- 2. Only haulers that have been authorized by the municipality will be permitted to haul bulk liquid sewage to the Village of Bethune lagoon site. Bulk liquid sewer haulers/contractors may complete an Application to Dispose of Liquid Domestic Sewage and submit to the municipality for authorization. Authorizations that are granted shall be for the calendar year and require to be renewed annually.
- 3. The charges set out in Section 1 shall be paid immediately to the municipality unless authorization has been granted by the Administrator to establish monthly invoicing to the contract hauler or company.
- 4. Accounts for services that are outstanding and not paid within the period of thirty days from the date of issue, the municipality may cancel permission granted to the hauler/contractor to haul liquid sewage to the lagoon site until the account is paid in full. When the service has been void it shall not be re-authorized until all outstanding amounts are paid in full together with a late payment fee of \$50.00.
- The municipality has the right to deny the acceptance of liquid sewage and materials that may not conform to the requirements of the Licence to Operate as provided by the Ministry of Environment.
- 6. The municipality, may, at its discretion, require a hauler/contractor to provide for sample testing prior to depositing any liquid sewage at the Village of Bethune lagoon site, if in the opinion of the municipality, the fluids being hauled contain materials and chemicals deemed to be hazardous or dangerous to the environment. The sole cost of performing these tests and submitting analysis information to the municipality shall be that of the contractor/hauler.
- 7. Any contractor/hauler found to be hauling liquid sewage to the Village of Bethune Lagoon site unauthorized and without Permit or depositing hazardous or environmentally sensitive materials without proper authorization, shall be guilty of an offense and liable upon summary conviction of a penalty under the General

Penalty Bylaw of the Village of Bethune.

8. This bylaw shall come into force and take effect on final passing thereof.
