A BYLAW TO ALTER STREET NAMES IN THE MUNICIPALITY

A BYLAW OF THE VILLAGE OF BETHUNE, IN THE PROVINCE OF SASKATCHEWAN
TO ALTER STREET NAMES IN THE MUNICIPALITY
ENACTED PURSUANT TO SECTION 157(1)(L) OF
THE URBAN MUNICIPALITY ACT, 1984, E.A.S., 1983-84, C.U.-11.

The Council of the Village of Bethune in the Province of Saskatchewan enacts as follows:

1. That an official system of naming streets and avenues in the Village of Bethune be established as shown on the plan of the Village of Bethune attached hereto and identified as Schedule "A" to this bylaw.
2. That the designation of certain streets and avenues in the Village of Bethune be altered in accordance with Schedule "B" to the bylaw.
3. Names of streets and avenues in the Village of Bethune shall remain as shown on Schedules "A" and "B" of this bylaw unless officially changed by an amending bylaw.

Wherefore your Petitioner prays that the Master of Titles' Order do issue an order directing:-


"That the registered plans of the Village of Bethune be amended changing the street and avenue names as indicated in Schedule "B" attached to Bylaw No. 1/89.
