A BYLAW TO PROVIDE A UNIFORM SYSTEM FOR THE NUMBERING OF HOUSES  
AND OTHER BUILDINGS IN THE VILLAGE OF BETHUNE

A BYLAW OF THE VILLAGE OF BETHUNE, IN THE  
PROVINCE OF SASKATCHEWAN TO PROVIDE A UNIFORM NUMBERING  
SYSTEM FOR THE NUMBERING OF HOUSES AND OTHER BUILDINGS  
IN THE VILLAGE OF BETHUNE ENACTED PURSUANT TO  
SECTION 157(1)(L) OF THE URBAN  
MUNICIPALITY ACT, 1984, E.A.A., 1983-84, C.U.-11.

THE COUNCIL OF THE VILLAGE OF BETHUNE, in the Province of Saskatchewan  
enacts as follows:

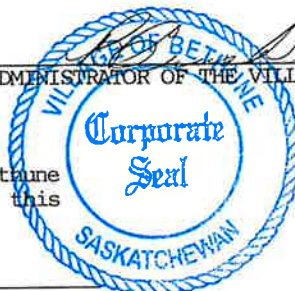
1. That a uniform system of numbering houses and other buildings as shown on the attached map and which shall become part of this bylaw shall be used in the Village of Bethune.
2. That all existing numbers of houses and other buildings not now conforming with the provisions of this bylaw shall be changed to conform to the system herein adopted.
3. A separate number shall be assigned for each 25 feet of frontage.
4. Each house and/or building shall bear the number assigned to the frontage on which the front entrance is situated. In cases of houses or buildings are occupied by more than one family dwelling unit or businesses, each separate front entrance of said house or building shall bear a separate number.
5. Numerals indicating the official number of each house or building or each front entrance to such building shall be posted in a manner as to be visible from the street on which the property is located.
6. The Administrator of the Village of Bethune shall be responsible for maintaining the numbering system and shall keep a record of all numbers assigned under this bylaw.
7. Any person who contravenes the provisions of this bylaw is guilty of an offence and upon conviction shall be liable to (The Penalty provided in the General Penalty Bylaw of the Village of Bethune).
8. Numerals may be obtained from the Village Office for a fee of \$3.00 for a set of three.
9. Numerals must be placed on the house front within 30 days of the receipt of the attached "Schedule A" notice.

"SCHEDULE A" OF BYLAW 2/89

TO THE OWNER, OCCUPANT OR AGENT OF THE PREMISES:

In accordance with a Bylaw adopted by the Mayor and Council of the Village of Bethune, establishing a uniform system of property numbering and street naming throughout the Village of Bethune, you are hereby notified that your correct address for this property is:

THIS IS YOUR OFFICIAL NOTICE THAT THE BUILDING WHICH YOU OCCUPY HAS BEEN ASSIGNED A NUMBER. In order to facilitate this notice, follow the instructions given below:

1. Within thirty (30) days after receiving this notice, submit the Form I below, to the Village Office, to obtain the correct house numerals along with the amount of \$3.00 for three numerals.
2. The numbers shall be placed immediately above, on, or at the side of the main entrance of each building so that the numbers can be plainly seen from the street. The numbers shall be placed on the building with 30 days after receiving this notice.
3. In order to cover the cost of supplying the house numbers and the expenses involved, a charge of \$1.00 per numeral is levied against the occupant, payable to the Village of Bethune.
4. Do not place numbers where they will be hidden at any time by obstructions, screen or storm doors, or shrubbery.
