BYLAW NO. 2025-03

A BYLAW OF THE VILLAGE OF BETHUNE TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

The Council of the Village of Bethune, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Municipality's water supply system and sewer services shall make application to the officials of the Municipality. Each application shall be accompanied by the payment of a deposit in the sum of \$150.00 for a 5/8" meter and \$200.00 for a 3/4" meter. The meter shall be installed in accordance with the Village of Bethune Water Metre Installation Policy #PW-PU-01.
2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
3. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
4. All persons desiring to be supplied with water from the Municipality's water supply shall pay a fee of \$50.00 for water service to be turned on. A \$50.00 fee shall apply for water services to be turned off. Accounts for water service and/or sewer service shall cover a period of **one month** and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of sixty days from the date on which such accounts are rendered. If an account is not paid within the period of sixty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$50.00 to cover the expense of turning off the water. Upon reconnection, a \$50.00 reconnection fee shall apply to cover the expense of turning on the water.
5. Accounts unpaid after a period of sixty days will be subject to a penalty of 12% per annum (1% per month).
6. Should circumstances warrant such actions, the Municipality may, by bylaw, ration or limit the amount of water furnished to all consumers.
7. Bylaw No. 2025-01 is hereby repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.
